Liability & Security:

Exhibitors must make provisions for safeguarding their goods, materials, equipment, and display. Neither the NCDR, nor the Gaylord National Resort & Convention Center will be responsible for the safety of exhibitors' property from theft, damage, accident, or vandalism.

NCDR recommends that each exhibiting company secure a rider policy to insure all booths and display items during transportation to and from NCDR.17, as well as during installation, exhibit days, and dismantling.
