Composite Measures

Composite measures summarize a site's performance on multiple individual performance measures. ACTION Registry reports on 6 composite measures.

Including:

- ✓ Overall Defect Free Care measures – endorsed by the National Quality Forum (NQF) – and it will be included in the ACC's Voluntary Public Reporting Program beginning in early 2018
- ✓ Discharge AMI performance composite measure, including:
 - Aspirin
 - Beta Blocker
 - ACE- or ARB for LVSD
 - Statin
 - Adult Smoking Cessation Advice
 - Cardiac Rehabilitation Referral



STEMI Systems of Care Measures

Including:

- ✓ Door to Balloon (Primary PCI) < 90 minutes
- ✓ First Medical Contact to Primary PCI < 90 minutes
- ✓ Arrival at First Facility to Primary PCI < 120 minutes
- ✓ Door to Needle (Thrombolytic) < 30 minutes
- ✓ Door to First ECG within 10 minutes of arrival

AMI Process of Care Measures

Including:

- ✓ Cardiac Rehabilitation Referral
- ✓ ACE Inhibitor at Discharge
- ✓ High Intensity Statin at Discharge
