EXHIBITOR PROSPECTUS RULES

By receiving your application for exhibit space at ACC's Quality Summit 2022, it is assumed you have read the terms as outlined below and agree to abide by these terms. Your application and booth assignment are subject to the acceptance of the American College of Cardiology.

Written confirmation will be sent upon receipt of signed application and payment.

- 1. WHO MAY EXHIBIT The exhibition is specifically for those companies' offering products, equipment, and services that are related to nursing education. ACC QUALITY SUMMIT may accept or reject other applications based on products being displayed. ACC QUALITY SUMMIT reserves the right to determine the eligibility of any applicant as an Exhibitor.
- LOCATION OF EXHIBIT SPACE Exhibit space will be assigned to Exhibitors by the ACC QUALITY SUMMIT on a "priority" or "first come, first-served" basis, and as much in accord with the Exhibitor's wishes as is reasonably and conveniently feasible. ACC QUALITY SUMMIT reserves the right to locate and/or relocate an Exhibitor's assigned exhibit space.
- **3. COST OF EXHIBIT SPACE** The cost of the exhibit space is \$3,000. Included in that cost: one 10' x 10' exhibit booth, a sixfoot skirted table and two chairs, a waste basket, an attendee list, Wi-Fi, and two-name badges per booth.
- 4. CANCELLATIONS Any cancellation must be made in a written notification to the ACC Quality Summit by emailing accmeetingservices@acc.org

For the Quality Summit, exhibitors canceling prior to August 19, 2022, will forfeit 50% of the full booth fee. Exhibitors canceling after Friday, August 19 will be charged full-space rental regardless of whether the space can be resold or not.

If the Exhibitor fails to pay 100% of the total contracted exhibit space fee on or before Friday, August 19, 2022, ACC Management may cancel the Exhibitor's participation and is free to assign the released space to other companies.

ACC Management retains the right to utilize cancelled space at its sole discretion.

No-Show Policy

Any booth unoccupied by 7am on Wednesday, September 14, 2022, may be regarded as a "no-show." The Exhibitor will be deemed to have cancelled the exhibit space contract, and, as such, the Exhibitor will pay as liquidated damages 100% of the total contracted exhibit space fee. All freight will be removed from the Exhibitor's booth and returned to the loading dock at the Exhibitor's sole expense, and ACC Management will be free to assign the space to other exhibiting companies or utilize the space at its discretion.

 DRAWINGS - Drawings for exhibitor prizes will be conducted at times specified by the ACC QUALITY SUMMIT exhibit manager. There is no limit to value of prizes, but the range of \$50 to \$200 is recommended.

- 6. **SMOKING** This is a non-smoking conference; no smoking will be allowed in conference sessions or exhibits.
- 7. CHARACTER OF EXHIBIT The ACC QUALITY SUMMIT reserves the right to restrict any exhibit that, because of noise, method of operation, materials, and any other reason, in the opinion of ACC QUALITY SUMMIT becomes objectionable and also to prohibit or remove any exhibit that, in the opinion of ACC QUALITY SUMMIT, may detract from the general character of the Exhibitions as a whole, or consists of product or services inconsistent with the purpose of the Exhibition, without liability for any refunds or other exhibit expenses incurred.
